## OAK WILT ON OAKWOOD UPDATE

The Oak Wilt Containment Trench is expected to be done by the end of September. Total length of the trench is expected to be about half a mile and cost about \$23,000.

The trench starts a little over 100 feet directly North of the current infection and goes West to Blue Hills, then follows Blue Hills South to Oakwood, then continues West on both sides of Oakwood for a little over 100 feet.

The trench also goes further South to the back of the affected properties along Oakwood, then continues East, and then turns back North to the Southern edge of Oakwood a little over 200 feet past the current infection.

Note that we were not able to completely encircle the infected area as recommended by the Texas A&M Forest Service, so there may be an eventual spread of Oak Wilt to the North East.

All property owners adjacent to the trench should be vigilant in watching for any breakout past the trench; if we catch these quickly they will be easier to stop.

Some of the trees inside the trenched perimeter will be treated with a fungicide that is 80% effective at saving the tree. In October/ November we plan to join forces to clear out the dead trees.

**UPDATE ON ROAD REPAIR & RESURFACING  
IN SUNSET CANYON**

The roads in Section V have been repaired and resurfaced except for one small section on Roy Creek. We are awaiting an answer as to why this short section has not been finished.

The roads in Section IV have been pretty much completed. There may be a few more areas to finish but it looks like most of the surfaces have been done.

The crews should be moving on to Section I pretty soon if they have not already done so. Once they get in a section the work progresses pretty fast.

Section II & III will follow Section I. There are a good number of repairs that need to be done in Section II/III before the resurfacing starts. There are potholes, the breaking down of several surface areas, and some side/edge work that needs to be completed.

Overall the work appears to be done in an excellent manner. The roads are a little bit messy for a few days after the surface is put down. The small gravel stays on the surface for several days to a week or so. Drive slowly to avoid any windshield damage. The surface is a little sticky at first but it gets much better after a few days. Overall a very good job. We are very lucky to have this done. It only happens every 10-12 years or so. Thanks to the Hays Country road crews for all the hard and very hot work. Thanks to our Commissioner for helping us get this done.

**UPDATE ON CONSTRUCTION**  
**PATRIOTS HALL IN SUNSET CANYON**

As many of our residents are aware, there is a new building being built in the old Commercial Section of Sunset Canyon on the south side of US290 between S. Canyonwood Drive and Canyon Bend Drive. Ten acres of land that consists of four commercial lots was purchased by a Non-Profit Organization called Patriots Hall. The Patriots Hall organization has been fund raising for some time and is now in the process of building the first building. This building will be the home of the Dripping Springs VFW Post 2933 and the American Legion Post 290. As you drive on US290 you can see the new building being constructed. We hope to be able to meet in this building by Oct or maybe Nov 2021.

There will then be several other buildings constructed in the near future to consist of a small Chapel and a large 7500 sq ft Conference Type Hall with office, library, and work space. The whole complex

is planned as a place for veterans and their families to meet and work and play. There are to be walking/ bike trails, playgrounds, a small fishing lake, workout facilities, and activities such as Yoga Classes and Art Classes. Plans may include Bee Keeping, Horseback Riding, and Gardening. A Wellness Clinic is also planned for our veterans.
