According to TXDOT and Hays County, construction on the intersection at Trautwein and Hwy 290 will begin at the end of October. Trautwein will be closed to through traffic from Oakwood to 290, so all traffic will be rerouted through Sunset Canyon via Oakwood Ln and Canyonwood Drive. Trautwein will still be accessible to local residents and visitors.

The website trautweinhaysco.com will be a source of updates throughout construction. At the bottom of the web page there is a place to sign to have updates delivered by email. Page 3 of this newsletter contains a flier with a QR code linking to the site and a map with proposed impacts and detours.

There has been some community concern about the impact of increased traffic flow through our winding residential streets. Barbara and Tom Funnell, residents on Oakwood Lane, spoke at a recent Board meeting, stating their intention to gather signatures of other residents on Oakwood Lane to request a traffic analysis from Hays County. The Hays County Traffic Calming Policy process is outlined on our website at https://sunsetcanyon.org/documents. #### PRESIDENT"S CORNER

On behalf of the SCLA Board, I would like to extend warm greetings to all 700+ Sunset Canyon residents as we close the chapter on another long, hot Summer. My name is Michael Whirlow. Having served in your USAF for 21 years then retiring in 2005, I am now serving you as your SCLA board president. My main objectives are encouraging neighbors to follow the Deed Restrictions for all of Sunset Canyon's five sections and presiding at meetings of the members and Board of Directors to see that resolutions are carried out. I couldn't be as successful without the significant contributions from our board members: Randy, Joan, Alan, Nancy, Sarah, Paul, Lynn, and August.

Wow! This year started off [again] with Mother Nature wielding her power, wreaking havoc on our beautiful oaks and utilities. This Spring, we reinvented our newsletter to inform, inspire, and share activities connecting each of us. To meet this goal, we lined up guest speakers with topics relevant to our community, such as:

 North Hays County Emergency Services District #1 May Tax Increase Ballot. Where we were presented with key data-points around the ballot – one being how the increase would still be below many of the surrounding providers (e.g. Pedernales, Buda,

- Wimberly, Kyle)
- Civilian Response to Active Shooter Events (CRASE). Our own Hays County Precinct 4 Deputy Constable Graham presented an engaging workshop educating ~ 70 residents on active shooters.
- Fentanyl Awareness. The hourlong presentation conducted by our own Hays County Deputy Sheriff Hipolito with the goal of protecting our community both young and old.

An issue concerning me is the statistic from our recent August 2023 meeting: since 2018 we've seen an average of only ~ 291 residents out of the ~ 732 remitting their \$35 membership annual fee. This translates to a mere ~ 40%. While this nominal fee is voluntary for most, I hope you can appreciate how it forces your SCLA board to get creative, and at times limits us, when making improvements both in safety and aesthetics to our community.

I hope that we can continue to all work together to make our community a great place to live. I invite your candid feedback and suggestions around all things Sunset Canyon (https://sunsetcanyon.org/). It will be my pleasure to meet you at our annual National Night out where you can find me in Section 5 on Roy Creek.

### **US 290 AT TRAUTWEIN ROAD CONSTRUCTION**

Hays County, in partnership with Texas Department of Transportation, is planning for improvements to Trautwein Road at the intersection of US 290 to increase visibility and safety for travelers. During construction, Trautwein Road will be closed to all through traffic from US 290 to Oakwood Lane. Local access will still be maintained for residents and their visitors. Construction is expected to start in October 2023 and be completed in Spring 2024.

#### **Improvements Include:**

- Lowering Trautwein Road at US 290 to improve visibility
- Adding a dedicated right turn lane from westbound US 290 to Trautwein Road
- · Adding retaining walls to Trautwein Road
- Improving intersection signal on US 290

#### **Detour Details**

Travelers attempting to access US 290 via **Trautwein Road** will be directed to turn west on Oakwood Lane and south on Canyonwood Drive.

Travelers attempting to access Trautwein Road via US 290 will be directed to turn north on Canvonwood Drive and east on Oakwood Lane.

Detour signage will be placed along the detour route, US 290 and Trautwein Road to help travelers navigate the detour and arrive at their destination.

#### **Timeline**





#### **What to Expect During Construction**

- Detour available through Oakwood Lane and Canyonwood Drive
- Construction hours are planned from sunrise to sunset, with some nighttime work as needed
- Noise may be louder during the day
- Lights will be used during darker work hours for the safety of crews and the traveling public. Safety lights will be directed away from nearby properties
