SAVE WATER AND MONEY

Outdoor irrigation systems account for more than half of all the water used during hot summer months. Much of this water is wasted due to poorly maintained equipment or incorrectly programmed controllers, which can lead to overwatering. Using too much water wastes resources and creates landscapes more prone to diseases and pests.



The Lower Colorado River Authority's WaterSmart Rebates program can help offset the cost of a water audit, implementing water-savings technology, upgrading irrigation systems and maintaining landscapes to help you save water and money.



BECOME WATER EFFICIENT

LCRA and its customers offer rebates for businesses, industries, schools, hospitals, churches and other institutions to help implement new water-saving equipment and practices.

WATER AUDITS

A water audit can help evaluate your water use and make you aware of any necessary repairs. Water audit rebates up to \$125 per hour for outdoor audits (not to exceed \$2,000), or up to \$125 per hour for indoor and outdoor audits (not to exceed \$5,000), are available. Pre-approval by LCRA staff is required.

WATER-SAVINGS TECHNOLOGY

Install water-savings technology, such as rainwater harvesting, cooling tower recycling or commercial ice machines, and receive a rebate of 50% of cost, up to \$20,000. A water audit and LCRA staff approval are required.

WATERSMART REBATES

LCRA offers rebates for 50% of the cost, up to \$5,000 per connection.

Indoor rebate

- Up to \$65 per high-efficiency spray rinse valve.

Irrigation rebates

- Up to \$5 per pressure-reducing head or nozzle.
- Up to \$100 per pressure-reducing valve or in-line regulator.
- Up to \$900 for soil moisture sensors.
- Up to \$20 per rain sensor.
- Up to \$500 for pre-approved WaterSense smart controllers.
- Up to \$300 per flow sensor.
- Up to \$40 per hose-end timer.





Pool rebates

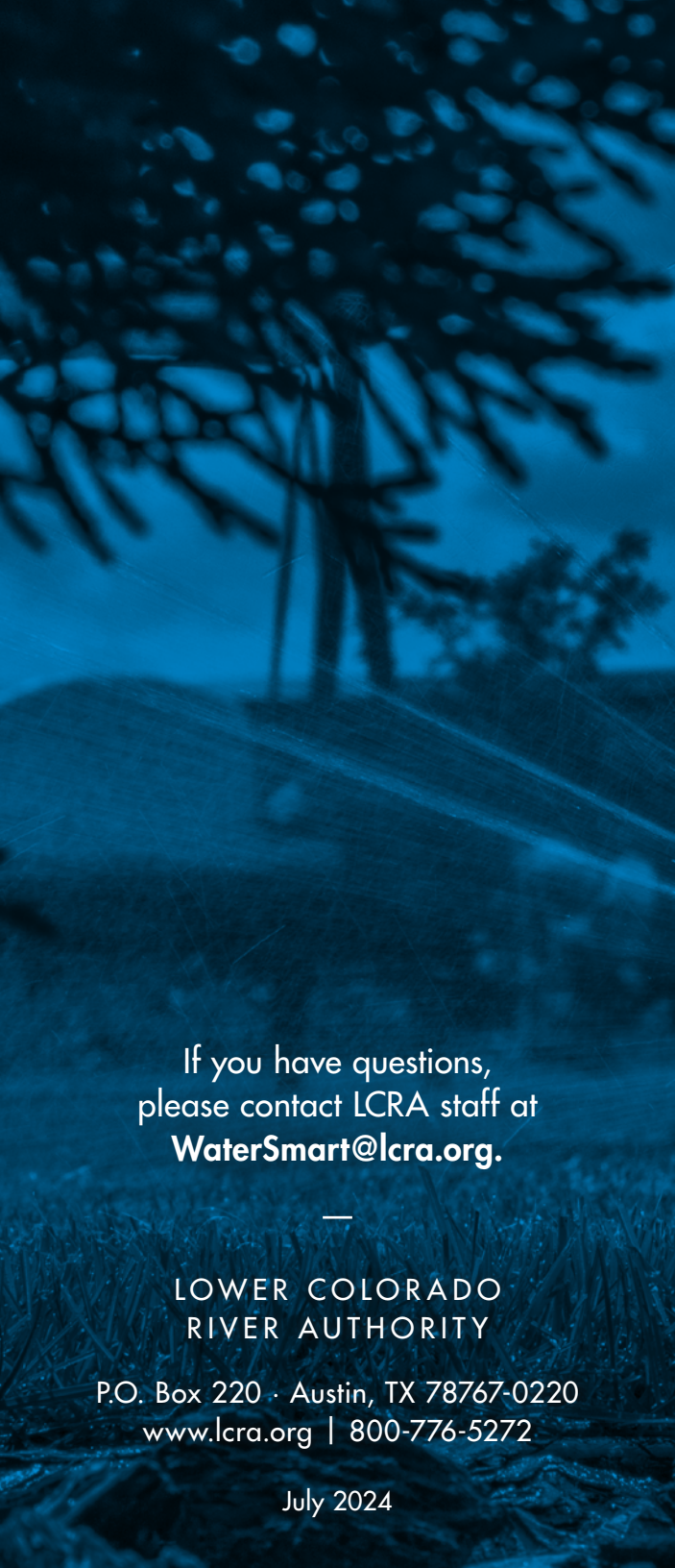
- Up to \$250 per high-efficiency cartridge pool filter.

Landscape rebates

- Up to \$100 for aeration equipment rental or contractor costs.
- 50% of the cost for compost and mulch (no Dillo Dirt™, rock or rubber).
- 50 cents per square foot, up to \$4,000, to convert healthy turf grass to native garden beds or drought-tolerant landscapes. Replacement landscapes may not include any turf grass or automatic irrigation.
(Pre-approval required.)
